

PREFACE

COP28 is a significant milestone in the ongoing efforts to combat climate change. Originating from the inaugural COP held in Berlin, Germany, in 1995, these conferences have played a pivotal role in driving transformative action on a global scale. Notably, the historic Paris Agreement, achieved during COP21 in 2015, stands as a testament to the profound impact of these gatherings. The COP serves as the United Nations Climate Change Conference, bringing together 197 countries, along with the European Union, as parties to the United Nations Framework Convention on Climate Change.

Driving Global Climate Action: COP28 UAE

As the highest decision-making body on climate issues worldwide, COP28 unites heads of state, climate experts, political leaders, young people, and civil society representatives. The conference serves as a crucial platform for governments and non-governmental entities to forge agreements, develop policies, and establish networks that drive progress in addressing the urgent challenge of climate change. With its collaborative nature and global participation, COP28 aims to catalyze collective action and create meaningful change in our shared pursuit of a sustainable future.

The COP28 location comprises of two primary zones, the Blue Zone and the Green Zone. Here's a concise overview of what you can anticipate in each zone:

1. Blue Zone

Managed by the **United Nations** Framework Convention on Climate Change (UNFCCC), is open to accredited parties and observer delegates. It serves as the site for formal negotiations, the World Climate Action Summit, country pavilions, and numerous side events, including panel discussions, round tables, and cultural events. *This zone is attended by parties (country negotiators), observers (NGOs, IGOs, and UN agencies), media, and world leaders. In the Blue Zone, approximately 60,000 to 80,000 UN-accredited participants are expected over the two weeks of the official summit. With around 20,000 daily visitors, including 4,000 members of the media, the Blue Zone will serve as a hub of activity. World leaders are also anticipated to attend a two-day summit, with numbers to be confirmed closer to the event.

2. Green Zone

Managed by the **COP28 Presidency**, provides a platform for non-accredited delegates, including the general public, youth groups, civil society, academia, artists, and businesses. It aims to amplify voices through events, showcases, workshops, and talks that promote dialogue, awareness, education, and commitment to climate action. **The Green Zone highlights various themes such as the private sector**, culture, family, civil society, inclusion, art and crafts, protestors, food, and refreshment. The COP28 UAE presidency recognizes the vital role of private enterprises in combating climate change and seeks to enhance the engagement of businesses in the Green Zone, encouraging them to showcase their innovative solutions, technologies, and products.

The **Green Zone welcomes 30,000 to 50,000** visitors daily, providing an inclusive environment for climate-focused activities. It caters to corporate representatives, offering a dedicated space for networking and connections. By fostering collaboration and knowledge exchange, it serves as a hub for addressing climate challenges and building partnerships. The Green Zone encourages engagement and serves as a dynamic platform for individuals and corporations invested in tackling climate change.

*Outside of the Blue and Green Zones, a range of activities is expected to take place across Dubai and Abu Dhabi. Stakeholders will organize fringe events. This activity is independent of the COP28 UAE delivery.
